

## LAS VEGAS ACES – “ALL IN WITH ALLY” SWEEPSTAKES

### OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING ANY PRIZE.

**PLEASE CAREFULLY REVIEW THESE OFFICIAL RULES. BY SUBMITTING AN ENTRY INTO THE SWEEPSTAKES (AS APPLICABLE), YOU ACKNOWLEDGE THAT YOU UNDERSTAND THESE OFFICIAL RULES AND AGREE TO BE BOUND BY ALL TERMS AND CONDITIONS HEREOF.**

The LAS VEGAS ACES “ALL IN WITH ALLY” SWEEPSTAKES (the “Event”) is sponsored by Las Vegas Basketball L.P. (“Sponsor”) and shall be administered by Sponsor or its designee (“Administrator”).

1. **SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes entry period begins at or about 7:00 PM Pacific Time (“PT”) on May 27, 2026 and ends at 11:59:59 PM PT on July 15, 2026 (“Sweepstakes Period” or “Entry Period”).

The Sponsor’s or Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY FOR SWEEPSTAKES:** Entry into the Sweepstakes is offered only to legal United States residents of the fifty (50) United States and the District of Columbia who 18 years of age or older at the time of entry. Residents of other countries are ineligible to enter the Sweepstakes.

Employees, directors, officers, and agents of Sponsor, Administrator, Ally Financial Inc., other entities affiliated with the Las Vegas Aces, and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, advertising and promotional agencies and suppliers involved in the Sweepstakes (collectively, “Sweepstakes Entities”), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. Only an individual meeting all of the eligibility requirements set forth in these Official Rules may participate in the Sweepstakes or win a prize. Void where prohibited or restricted by law.

Entrants may not have been convicted of a felony or a crime of moral turpitude. By entering, each Sweepstakes entrant understands and agrees that, if selected as a potential Grand Prize Winner, he/she will be required to consent to a background check to verify eligibility. A potential Grand Prize Winner’s guest for the Trip (as defined below) may also be required to consent to a background check. The failure of a potential Grand Prize winner and/or guest to provide such consents and authorizations and/or to furnish all required information will result in disqualification from receiving any Prize.

In addition, Sponsor reserves the right, in its sole discretion, to disqualify a potential Grand Prize Winner and/or guest based on the results of such background check. If disqualified, a person (whether the Grand Prize Winner or his/her guest) will not receive any compensation of any kind nor will Sponsor or the other Promotion Entities have any liability to him/her under any legal theory.

- 3. HOW TO ENTER THE SWEEPSTAKES:** Eligible entries must be submitted during the Entry Period. Entry into the Sweepstakes may be undertaken by visiting <https://go.lasvegasaces.com/allinally>, and completing the Sweepstakes entry form (including acknowledgement of and agreement to these Official Rules).

Entry into the Sweepstakes may be undertaken by providing all of the information requested on the entry form which may include, without limitation: entrant's first and last name (initials are not permitted), valid e-mail address, complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number and affirmation that he/she has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes for such Entry Period.

Submission of any entry for the Sweepstakes constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

**Entry and Prize Limit:** An individual is limited to submitting one Sweepstakes entry during the Entry Period. If more than one (1) entry is received from the same name, telephone number and/or e-mail address, only the first entry received may be considered valid. In addition, an eligible entrant's household is limited to winning only one (1) Prize (which shall be the first or initial Prize won by any eligible entrant in such household).

- 4. RANDOM DRAWING:** On or about July 16, 2026, the Sponsor or Administrator will randomly select one (1) winner from all eligible entries received during the Entry Period (the "Random Drawing"). The winner will be considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

**5. PRIZE, APPROXIMATE RETAIL VALUE ("ARV") AND ODDS OF WINNING:**

**A. Grand Prize (3 total):** The Sweepstakes will have three (3) Grand Prize winners. The prize received by the winner shall be as follows (the "Prize"): a 3-day/2-night trip for the winner and one guest to a 2026 Las Vegas Aces regular season away basketball game to be selected by Sponsor in its sole discretion (the "Trip"). The Trip includes:

- Economy roundtrip airfare for two (2) individuals (the winner and a guest) on an air carrier selected by Sponsor between Harry Reid International Airport and an airport in or around the selected away team city (baggage charges, airport parking charges, ground transportation charges, taxes and any other additional charges incurred after the issuance of airline tickets and/or in connection with the flight are not included) (\$500/round-trip value; \$1,000 total value)
- Accommodations consisting of one (1) Sponsor-selected standard double occupancy hotel room for two (2) nights in or around the selected away game city (meals, telephone calls, tips/gratuities, room food/beverage charges, and other incidentals and additional costs incurred in connection with the hotel stay are not included) (\$750 total value)

- Two (2) tickets to the selected Las Vegas Aces away basketball game (in-game food, meals and beverages, game parking, transportation to the game, or other additional costs are not included) (\$250 per ticket, \$500 total value)
- One (1) autographed Las Vegas Aces jersey (\$500 total value)
- \$1,000 awarded in the form of a VISA gift card

Total estimated value of the Grand Prize is \$3,750. The actual retail value of the Grand Prize may fluctuate based on the selected away game location and date, the date and times of travel, airfare fluctuations, and lodging price fluctuations, and the date of travel booking by Sponsor or Administrator. Therefore, the actual value of the Grand Prize may be lower or higher at the time of its fulfillment by Sponsor. If the actual value of the Grand Prize is less than the estimated values stated above, Sponsor shall not award or pay the difference to the winner. The Trip must be taken on the dates and times designated by Sponsor or prize will be forfeited in its entirety and may be awarded to an alternate winner. Sponsor reserves the right to change dates, including the selection of the away game. The Grand Prize winner and their guest on the Trip must travel together on the same itinerary. If guest is a minor, his/her parent/legal guardian must be the Winner and a parent/legal guardian must sign any applicable required documentation on the guest's behalf. All expenses not specifically mentioned herein are not included and are solely the Grand Prize winner's responsibility. Airline carrier and hotel regulations and conditions apply. Grand Prize winner and guest are responsible for any and all baggage charges, taxes and any other charges incurred in connection with the Trip. Grand Prize winner may be required to provide a credit card to the hotel selected by Sponsor in order to cover additional expenses or incidentals which are not included in Grand Prize package. Winner and guest must have all necessary identification and/or travel documents required for travel. Sponsor is not responsible for changes in schedule of any element of the Trip or for any expenses incurred as a consequence of any flight cancellation, adjustment or delay. Sponsor is not responsible and will have no liability if Grand Prize winner and/or guest is for any reason not permitted to travel by the relevant airport or other travel authorities, or misses a flight or other travel element of the Trip.

**B. Odds of Winning:** The odds of winning the Prize depend on the total number of eligible entries received during the applicable Entry Period.

**C. General:** In no event will additional Prizes or items than are stated in these Official Rules be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. Limit of one (1) Prize per person/household. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right (but not the obligation) to substitute a prize of equal or greater value in case of unavailability of a Prize or force majeure. Sponsor and Administrative shall not pay for or reimburse winner's travel, lodging, meals or other expenses incurred in redeeming Prize. The winner is solely responsible for any travel, lodging, meals or other expenses that may required for such winner to utilize the Prize.

**6. HOW TO CLAIM A PRIZE OR ITEM:** Each potential winner is subject to verification of eligibility and compliance with these Official Rules. A potential winner will be notified by telephone or e-mail after the Random Drawing with instructions on how to claim the Prize. Failure to provide all required information within the stated time period, including any tax-related documentation, may result in forfeiture of winner's right to claim the Prize, and may result in the Prize being awarded to an alternate winner. A potential winner will be subject to a background check before the Prize is awarded, and the potential winner's guest for the Trip may also be subject to a background check before the Prize is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check(s) if Sponsor determines in its sole discretion that awarding the Prize to such individual might reflect negatively on the Sponsor. Upon verification of eligibility, any physical components of the Prize will be mailed to the winner at their physical address provided (P.O. Boxes are not permitted), and any other components of the Prize will be e-mailed to the winner at their provided e-mail address. Las Vegas Basketball L.P., any entity affiliated with the Las Vegas Aces, and each of their respective parent companies, subsidiaries, affiliates, divisions, suppliers, distributors, advertising/promotion agencies, and each such company's officers, directors, employees, representatives and agents (each, an "Aces Entity," and, collectively, the "Aces Entities") and the Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the Prize, or any winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if a potential winner does not answer the initial telephone notification or e-mail, the Prize may be forfeited. If a Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible entries received during the applicable Entry Period, time permitting. If, after a good-faith attempt, Sponsor is unable to award or deliver the Prize, the Prize may not be re-awarded. A winner may not request that the Prize be transferred or assigned to any third party, the Prize only includes the items specifically listed above as part of the Prize. Any portion of the Prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes or fees arising from their receipt of the Prize, and Sponsor shall undertake any required tax withholdings, deductions or reporting as may be required under applicable law. Approximate retail value of the Prize is as of the time these Official Rules were printed and the value of the Prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Prize will only be awarded to a verified eligible winner.

**7. INDEMNITY AND LIMITATION OF LIABILITY:** By entering the Sweepstakes or accepting any prize or item, all Entrants expressly agree to indemnify, defend, and hold harmless, and do hereby forever waive, release, discharge, and covenant not to sue the Aces Entities, the Sweepstakes Entities, the Women's National Basketball Association, and/or any of their past and present partners, limited partners, owners, affiliates, members, managers, entity owners (and the current and former officers, directors, shareholders, partners, members, limited partners, managers, affiliates, assigns and employees of any owners or entity owners), employees, agents, attorneys, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, directors, officers, shareholders, contractors, successors, assigns and insurers (collectively "Released Parties"), for and from any and all

claims, debts, liabilities, demands, obligations, costs, fees, expenses, actions and causes of action whatsoever, of every nature, character and description (collectively, "Claims"), known and unknown, including, but not limited to, all those arising out of or in any way related to the Sweepstakes, these Official Rules (including the legality of these Official Rules or any portion hereof); Entrant's entry into and/or eligibility for the Sweepstakes; the negligence of Las Vegas Basketball L.P. or any Aces Entity; the Prize (including without limitation the receipt, non-receipt, acceptance, rejection, possession, misuse or use of the Prize, and any travel or other expenses that the Winner incurs to utilize the Prize); any purchase of tickets; any participation in the Sweepstakes; and any presence at any Sweepstakes-related or Prize-related venue (including without limitation any arena/stadium or on the court, field or sideline thereof). Entrant represents and warrants that he or she owns and/or has the authority to release the Claims stated herein expressly waives Section 1542 of the California Civil Code, which provides:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

The Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes, and (viii) Sweepstakes entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Released Parties are not responsible for any undelivered text messages or e-mails, including without limitation, e-mails that are not received because of an entrant's privacy or spam filter settings that may divert any winner notification or other Sweepstakes or Event-related e-mail to a spam or junk folder.

Without limiting anything in the foregoing and solely for purposes of clarity, any participant in the Sweepstakes agrees: (i) to be bound by these Official Rules, including entry requirements; (ii) to waive any rights to claim ambiguity with respect to these Official Rules; (iii) to waive all of his/her rights to bring any claim, action or proceeding against any of the Released Parties in connection with the Sweepstakes; and (iv) to forever and irrevocably agree to release and hold harmless each of the Released Parties from any and all claims, lawsuits, judgments, causes of action, proceedings, losses, demands, fines, penalties, liability, costs and expenses (including, without limitation, reasonable attorneys' fees) that may arise in connection with: (a) the Sweepstakes, including, but not limited to, any Sweepstakes-related activity or element thereof, and the entrant's entries, participation or inability to participate in the Sweepstakes; (b) the violation of any third-party privacy, personal, publicity or proprietary rights; (c) acceptance, attendance at, receipt, travel related

to, participation in, delivery of, possession, defects in, use, non- use, misuse, inability to use, loss, damage, destruction, negligence or willful misconduct in connection with the use of the Prize (or any component thereof), including, but not limited to, personal injury, death, or damage to or loss of property; (d) any change in the prizing (or any components thereof); (e) human error; (f) any wrongful, negligent, or unauthorized act or omission on the part of any of the Released Parties; (g) lost, late, stolen, misdirected, damaged or destroyed prizing (or any element thereof); or (h) the negligence or willful misconduct by entrant.

If Sponsor determines (in its sole and absolute discretion) that, for any reason, the Sweepstakes is not capable of running as planned, or the integrity and/or feasibility of the Sweepstakes is undermined by any event beyond the control of Sponsor, including but not limited to fire, flood, epidemic, pandemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, hacking or infection by computer virus, unauthorized intervention, technical failures or other cause not reasonably within the control of Sponsor (each a "Force Majeure" event or occurrence), Sponsor reserves the right, at its sole and absolute discretion, to abbreviate, cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of winners in a manner it deems fair and reasonable, including the selection of winners from among eligible entries received prior to such cancellation, termination, modification or suspension without any further obligation provided a sufficient number of eligible entries are received. If Sponsor, in its discretion, elects to alter this Sweepstakes as a result of a Force Majeure event, a notice will be posted at the Website.

WITHOUT LIMITING THE FOREGOING, EVERYTHING REGARDING THIS SWEEPSTAKES, INCLUDING THE PRIZES, IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT.

- 8. DISPUTES: THESE OFFICIAL RULES SHALL BE CONSTRUED AND INTERPRETED ACCORDING TO THE LAWS OF THE STATE OF NEVADA WITHOUT REGARD TO CHOICE OF LAW PRINCIPLES. AS A CONDITION OF PARTICIPATING IN THE EVENT (INCLUDING THE PROMOTION AND SWEEPSTAKES), EACH ENTRANT AGREES THAT ANY AND ALL DISPUTES WHICH CANNOT BE RESOLVED BETWEEN THE PARTIES, AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE EVENT, INCLUDING THE PROMOTION AND SWEEPSTAKES COMPONENTS, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, EXCLUSIVELY BEFORE A COURT LOCATED IN CLARK COUNTY, NEVADA HAVING JURISDICTION. PUBLICITY RIGHTS:** By participating in the Promotion and Sweepstakes and/or accepting the Prize, each entrant hereby grants to Sponsor, the Aces Entities, and their designee(s) a non-exclusive, royalty-free worldwide, perpetual right and license to use his/her name, information, photos and likeness, voice recording, video images and all related footage, and statements for Sweepstakes, trade, commercial, advertising and publicity purposes, at any time or times, in all media now known or hereafter discovered worldwide including but not limited to television (including live television), radio, Internet, without notice, review or approval and without additional compensation except where prohibited by law.
